1. Fees must accompany application and are non-refundable after letter of confirmation is sent
2. **Your space will be assigned when your application is received. If you are with a licensed company, you must call the chairperson first.**
3. All space renters will observe the opening and closing times. No early closings.
4. No flea market items.
5. Set up time: Friday September 22nd 5:00-8:00 P.M. (*NO Earlier than 5:00 PM!!!!!!*)
6. Crafters are required to clean up their own display area during the show and after dismantling.
7. Outside security will be provided from 11 p.m. Saturday until 7:00 a.m. Sunday.
8. No parking is permitted within the craft area-except for loading and unloading.
9. No subleasing of your space will be permitted.
10. Violation of any rule may jeopardize your participation in future Grape Jamboree shows.
11. Each crafter is responsible for his/her own vending license.
12. A \$30 check fee will be charged for insufficient funds.
13. The Grape Jamboree has final say if an item for sale is deemed inappropriate. The City of Geneva has prohibited the sale of the Confederate flags at the Grape Jamboree. In such case, the vendor may be asked to remove the item(s). Failure to comply will result in expulsion from the show.
14. Failure to comply with the instructions of the Geneva Grape Jamboree Committee or its officers will result in expulsion from the show.
15. Vendors with licensed companies (Avon, Scentsy...) must verify with craft chairperson first
16. **Application deadline is September 1, 2023.**

#### **Waiver/Release for Communicable Diseases Including COVID-19 and its variants.**

In consideration of being allowed to participate on behalf of the **Geneva Area Grape Jamboree, Inc.** related events and activities, the undersigned acknowledges, appreciates, and agrees that:

1. Participation includes possible exposure to and illness from infectious diseases including but not limited to MRSA, influenza, and COVID-19. While particular rules and personal discipline may reduce this risk, the risk of serious illness and death does exist; and,
2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation; and,
3. I willingly agree to comply with the stated and customary terms and conditions for participation as regards protection against infectious diseases.
